

The U.S. Dollar is the currency used to express performance. Although there is no clearly comparable benchmark, the composite is measured against the MSCI EAFE Value Index Net USD. The MSCI EAFE Value Net Index is based on the MSCI EAFE Index, its parent index, and includes large and mid-cap stocks across Developed Market countries around the world, excluding the US and Canada. The value investment style characteristics for index construction are defined using three variables: book price to value, 12-month forward earnings to price and dividend yield. The index has 461 constituents and the index targets 50% coverage of the free float-adjusted market capitalization of the MSCI EAFE Index.
